

# **Plans with Virtual Connect Plus**

All plans with Virtual Connect Plus offer \$0 virtual primary care, on-demand sick/urgent and behavioral health care through CloseKnit<sup>\*</sup>, as well as in-person primary care (well and sick visits) at select in-person providers. Members with an HSA-qualified plan will pay \$0 for non-preventive care after meeting the deductible. Once the member has met their deductible, they will pay \$0 for eligible services.

Please refer to your contract or open enrollment materials for benefit eligibility and full details, including the name of your specific plan.

Important note: Government programs, such as Medicaid and Medicare, are not eligible for Virtual Connect and/or Virtual Connect Plus.

## **Employer group plans (those who elect coverage through their employer)**

- Your plan renews anytime between January-December depending on your employer's renewal period.
- Once your plan renews, you will have Virtual Connect Plus in the following plans.
